During this time I was introduced to AAHPERD's APAC organization and the National Consortium for Physical Education and Recreation for Individuals with Disabilities. I began attending the NCPERID conference and for the first several years I was an outsider, not a big grant recipient with lots of money to pay students to attend my university. However, I kept attending the annual summer conference and eventually got to know some of the big hitters in our profession. The Sky's the Limit!

I actually got a job at a

medium-sized university where we began an undergraduate minor in Adapted Physical Activity. Two years ago a colleague submitted my name to run for President of the NCPERID, Anything is Possible!

Indiana New Beginning Teacher Standards in Physical Education

In January 2006 the Indiana Professional Standards Board, a division within the Department of Education, conducted the first review of beginning teacher standards for physical education and health. These standards had been in place for seven years prior to this review. The state of Indiana utilizes performance based licensing which is predicated on these standards. Prior to this review physical education and health education shared licensure titles i.e. Physical Education: PE/Health. The area of Adapted Physical Education had a separate licensure and was considered by most institutions of higher education to be an add-on licensure area. This review changed the licensing pattern and made history for Indiana.

Fifteen professionals from around Indiana applied for and were accepted to be members of the review committee. These professionals represented the content areas of physical education, health, athletic training, and administration from public school through university settings. The charge was to consider either maintaining the licensure pattern currently in place i.e., combined physical education and health with separate adapted physical education, or present a new licensure model. A new licensure model prevailed.

Sub-committees were organized to produce a combined license in physical education and adapted, and a separate

health license. The remainder of this article will only reflect the activities related to the physical education/adapted physical education sub-committee.

The physical education/adapted sub-committee worked to combine the NASPE Beginning Physical Education Teacher standards with those from the Adapted Physical Education National Standards or APENS (www.cortland.edu/apens). Cross-matrix charts and tables were used as working documents to help each member align the two sets of standards. Work on this project started in August 2005 and concluded January 2006. Several working drafts were reviewed, edited, and critiqued throughout the process before a final version was ready for posting. Policy dictated that the proposed new standards be posted for public review for 30 days. All posting occurred on the Indiana Department of Education's web site, with comments sent directly to the Coordinator of the Review Committee. Once the comments period was completed, the committee worked to condense and implement suggested changes. Much of the edits had to do with language related to individuals with disabilities as each of the ten new standards utilized people first language. The final version of the new

standards was presented to the Department of Education for acceptance, which was granted on January 18, 2006. As a result, beginning in 2008 the new teacher licensing for physical education will read: Physical Education/Adapted Physical Education. For the first time in Indiana history all students licensing in Physical Education will also be licensed in Adapted Physical Education. The new licensing will take effect in 2008, which means institutions of higher education must begin to address such training in their undergraduate teacher preparation curriculums. Because many smaller programs might have difficulty delivering coursework in adapted physical education other forms of delivery need to be investigated i.e., video conferencing, on-line, or blended delivery which could be a combination of traditional and on-line. Whatever is decided this is an exciting new development for the preparation of young professionals,

one that could serve as a model for other states to consider. The Indiana teaching standards for physical education are posted on the NCPERID web site (<http://www.uwlax.edu/sah/ncperid/>), please take a moment to read.

CAPE UPDATE: If you are a current CAPE and a member of the NCPERID, APENS is looking for **STATE COORDINATORS!** If you are interested, your role will be to share our vision by helping to put "A CAPE IN EVERY DISTRICT IN THE COUNTRY"! There are over 14,000 public school districts that serve the approximate 5.2 million children

with disabilities in the United States. APENS is concerned that for so many of those children, qualified Adapted Physical Educators are not available or possible for the district to hire. Therefore, general Physical Educators are often left to manage with little or no experience or training. In addition, the majority of states do not offer a certification in Adapted Physical Education or require certification to teach Adapted Physical Education. The 15 Standards detailing the comprehensive knowledge Adapted Physical Educators need to know is available for Adapted Physical Education and general Physical Education teachers

to review, study, and ultimately demonstrate by sitting for the APENS exam. If a district is unable to hire or find a qualified Adapted Physical Educator, they should at least provide the opportunity for an existing general Physical Educator to learn the 15 Standards and demonstrate that knowledge by taking the APENS exam.

Competing Alongside Able-bodied High School Track Athletes

April 22, 2006 in Columbia Maryland was a day to remember. Tatyana McFadden raced alongside able-bodied runners while she raced in her wheelchair at a high school track meet.

Ms. McFadden, a sophomore at Atholton High School in Howard County was born with spina bifida and paralyzed from the waist down has been racing alone at the high school track meets previously. But this April she was racing alongside, though not against her able-bodied peers. McFadden was scored separately and finished the 1600 meter



race in 4 minutes and 37.12 seconds.

The raced marked a milestone for the school system. It was the first time a wheelchair athlete would be in the same race as able-bodied peers. A preliminary injunction was issued that cleared the way for McFadden to participate. The injunction ordered that she compete in a separate wheelchair event that would take place alongside able-bodied athletes. Both McFadden and the able-bodied winner of the race would earn

points for the team.

- Cindy K. Piletic (Western Illinois University)


Member at Large:
